



## PROREIT ANNOUNCES VOTING RESULTS FROM 2018 ANNUAL MEETING OF UNITHOLDERS

June 5, 2018 - Montreal, Quebec - PRO Real Estate Investment Trust (“**PROREIT**” or the “**REIT**”) (TSXV: PRV.UN) is pleased to announce the voting results from its annual meeting of unitholders held today in Montreal, Quebec.

A total of approximately 19.4% of the issued and outstanding voting units of the REIT were represented either in person or by proxy at the meeting, and each of the eight trustees of the REIT was re-elected as trustee of the REIT. Based on proxies received prior to the meeting, each trustee was re-elected by a substantial majority as follows:

The REIT’s external auditor was also reappointed at the meeting, and the amendment to the REIT’s long term incentive plan to increase the number of units of the REIT that may be issued thereunder, as described in the proxy circular of the REIT dated May 4, 2018 prepared in connection with the meeting, was also approved at the meeting by disinterested unitholders.
